Authorize the Superintendent and Business Manager to enter into a lease-purchase agreement in an amount not to exceed \$350,000, for the purpose of structural reinforcement of the Mill Pond roof, for a term of 15 years or less, contingent upon securing an interest rate of 5.4% or less. This authorization includes the ability to finalize terms and execute all necessary documents, provided that the financing structure remains within the parameters outlined above and is determined to be in the best financial interest of the District
